INTRODUCTION

This Privacy Policy describes the policies and procedures of <http://www.dcbizroadshow.kr/>. ("dcbizroadshow ", "we", "our" or "us") on the collection, use and disclosure of the information of business entities and customers on of <http://www.dcbizroadshow.kr/>. (the "Site") and the services, features, content or applications we offer (collectively with the Site, the "Services"). We receive information about you from various sources, including: (i) if you register for the Site and the Services, through your user account on the Services (your "Account"); (ii) your use of the Services generally; and (iii) from third party websites and services. When you use the Services, you are consenting to the collection, recording, organization, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure or destruction and other uses of your information as described in this Privacy Policy.

PRINCIPLES OF www.dcbizroadshow.kr PRIVACY POLICY

www.dcbizroadshow.kr does not rent or sell your personal information. We don't share your personal information with anyone except to comply with the law, to provide a service you have requested, to protect our rights, or as provided in this Privacy Policy. We don't store personal information on our servers unless required for the on-going operation of one of our Services.

WHAT THIS PRIVACY POLICY COVERS

This Privacy Policy covers the treatment of personally identifiable information ("Personal Information") gathered when you are using or accessing the Services. This Privacy Policy also covers our treatment of any Personal Information that our business partners share with us or that we share with our business partners. This Privacy Policy does not apply to the practices of third parties that we do not own or control, including but not limited to any third party websites, services and applications ("Third Party Services") that you elect to access through the Service or to individuals that we do not manage or employ. While we attempt to facilitate access only to those Third Party Services that share our respect for your privacy, we cannot take responsibility for the content or privacy policies of those Third Party Services. WHAT INFORMATION DO WE COLLECT?

ACCOUNT INFORMATION

www.dcbizroadshow.kr collects Personal Information, such as your email address, when you create an Account with www.dcbizroadshow.kr to use the Services. You acknowledge that this information may be personal to you, and by creating an account on the Services and providing Personal Information to us, you allow others, including us, to identify you and therefore may not be anonymous.

INFORMATION SHARING AND DISCLOSURE

When you access or use the Services, we collect, use, share, and otherwise process your personal information as described in this Privacy Policy. We process your personal information when you have given consent to the processing and when the processing is necessary:

- For us to provide the Services to you.
- For compliance with a legal obligation.
- To protect the vital interests of yourself or others.
- In the public interest.
- For the purposes of our legitimate interests or those of a third party.

EDITING AND DELETING ACCOUNT INFORMATION

You can delete your Account username at any time. You can edit and change other Account information at any time. You can delete your Account at any time from your Account page; however, please note that your identification and contact information may remain www.dcbizroadshow.kr 's records for some period. If you delete your Account, any association between your Account and information we store will no longer be accessible through your Account. However, given the nature of sharing on the Services, any public activity on your Account prior to deletion will remain stored on our servers and will remain accessible to the public unless requested to be removed.

DATA SECURITY AND CHANGE OF CONTROL

Your Account information is password-protected. You need to prevent unauthorized access to your Account and Personal Information by selecting and protecting your password appropriately and limiting access to your computer and browser by signing off after you have finished accessing your Account.
